

## COOKIES POLICY

### INTRODUCTION AND WHO WE ARE

GPS Capital Markets, LLC (the United States) and its subsidiaries including GPS Capital Markets Europe, UAB (Lithuania), GPS Capital Markets Limited (the United Kingdom), GPS Capital Markets Australia Pty Ltd (Australia) are hereby referred to as "**GPS**" or the "**Company**", are processing your data in accordance with the provisions of the General Data Protection Regulation (EU) 2016/679 as well as other legal acts regulating this area.

Our website and services delivered online use cookies and other similar technologies to distinguish you from other users when you browse our websites or use our online services and to allow us to improve our online services, amongst other use cases.

This document applies to our website and online services, including [www.gpsfx.com](http://www.gpsfx.com), [fxpert.gpsfx.com](http://fxpert.gpsfx.com) and any other website, mobile app or other online service created or hosted by us from time to time on which this Cookies Policy appears (together, our "**online services**") through which we may collect certain details if, for example, you want to subscribe to any publications or newsletters that we may periodically issue.

### ABOUT COOKIES

Cookies are small text files that are placed on your devices (e.g. computer, mobile phone, tablet) by websites that you visit. They are widely used in order to make websites work or work more efficiently, to improve the user experience as well as to provide certain information to the owners of the site.

We may, for example, collect information about the type of device you use to access our online services, the operating system and version, your IP address, your general geographic location as indicated by your IP address, your browser type, the content you view and features you access on our online services, the web pages you view immediately before and after you access our online services, whether and how you interact with content available on our online services, and the search terms you enter on our online services.

### REASONS FOR USING COOKIES

- To ensure that our website functions properly;
- To improve the website's performance and security;
- To improve the website's appeal and a user experience including personalisation;
- To conduct more effective marketing.

### COOKIE USAGE

Cookies are categorized into groups based on functionality:

#### Strictly Necessary Cookies

These cookies are necessary for the website to function and disabling them in our systems is not possible. They are usually set only in response to actions you take, which are equivalent to service requests, such as setting privacy



preferences, logging in, or filling out forms. You can set your browser to block these cookies or alert you about them, but in such cases, some parts of the website may not work.

### Performance Cookies

These cookies allow us to count website visits and traffic sources, enabling us to evaluate and improve website performance. They help us determine which website pages are the most and least popular and track how visitors navigate the website. All information collected by these cookies is aggregated and therefore anonymous. If you do not allow these cookies, we will not know when you visited our website.

### Advertisement

We use cookies to make our ads more engaging and valuable to site visitors. Some common applications of cookies are to select advertising based on what's relevant to a user, to improve reporting on the ad campaign performance, and to avoid showing ads the user has already seen.

### Analytics Cookies

These cookies help us understand how visitors engage with the website. We may use a set of cookies to collect information and report site usage statistics. In addition to reporting site usage statistics, data collected may also be used, together with some of the advertising cookies described, to help show more relevant ads across the web and to measure interactions with the ads we show.

Cookies can also be categorized into first-party and third-party:

### First-Party Cookies

These are our own cookies implemented on our website that you are visiting.

We also use cookies to help secure user accounts in FXpert. This cookie is used to increase account security on public networks. This cookie also allows GPS to improve the user login experience. This cookie is encrypted and does not store any personal identification information pertaining to either the user or company.

### We Use Google Analytics

Google Analytics gathers information about the use of our website by means of cookies. The information gathered is used to create reports about the use of our website.
